John Gallant: The Battle of the Atlantic - Defeating the Nazis on the High Seas!

Haverhill's John Gallant served in the Atlantic Theater of Operation during World War II on the U.S.S Hammann, DE-131. The story of John Gallant's World War II naval service and that of his ship's, are very much the same tale.

With only eight officers, and around two hundred enlisted sailors, all performing very different but equally important jobs, a World War II Destroyer Escort was simply an extension of the men who served on her.

Destroyer Escort 131 was an Edsall-class ship, built for the primary role of protecting U.S. Merchant Marine convoys

against German and Japanese air or submarine attacks. The ship was named after World War I Medal of Honor recipient Charles Hammann, a U.S. Navy enlisted Seaplane pilot.

To drive home to our readers, just how close John Gallant's naval war came to the Merrimack Valley he grew up in, I did a little research. After a quick search, I found numerous stories of German U-Boats being sunk by the U.S. Navy and the U.S. Coast Guard off our New England shores. A recent one is the Maine's Press Herald article published in July of 2012 on divers finding the wreck of Germany's U-550, off Nantucket Island. The Nazi submarine was sunk after a joint attack by the U.S. Navy's USS Gandy, USS Joyce, and USS Peterson. But not before the U-550 successfully torpedoed the Merchant Marine tanker SS Pan Pennsylvania, sending 140,000 barrels of gasoline destined for Great Britain's war effort up in flames.

After construction and commissioning, the USS Hammann departed in June of 1942 for Bermuda to conduct post construction shakedown operations, afterwards returning to Philadelphia, Pennsylvania. The ship then sailed to Norfolk, Virginia, and began the first four picket duty passages across the Atlantic to Casablanca, Morocco. This was during the peak of German U Boat activity in the "Battle of the Atlantic". The ship made several attacks on German submarines, but U.S. Navy records contain no confirmed kills of Nazi submarines by the



Hammann.

Serving in the U.S. Navy as an Electrician's Mate First Class, John Gallant made no less than six more voyages successfully convoying to and from Europe, stopping at ports in Northern Ireland. Later the USS Hammann changed her convoy destination to Liverpool and made four more voyages protecting the vital flow of supplies for allied effort to win and end the war against the Germans. During one trip, the USS Hammann was called upon to aid one of the ships in her convoy, the

EDITORIAL: Let's Stop Blaming Methuen Police for City's Financial Problems

The City of Methuen is in a financial mess that has resulted in the mayor and city council having to borrow \$4M from the state.

That \$4M loan comes at a heavy price. That price is state control over the city's finances in the form of either a fiscal overseer or a financial control board. It also comes with a price to the citizens of Methuen by way of cuts to police, fire, elder, and veteran's services.

If you read the Eagle-Tribune every day you might get the impression that Methuen's financial woes are because of greedy police officers making too much money, buying lavish SUVs, and "stacking" the salaries of their superior officers.

It's not.

The fact is, Methuen is borrowing \$4M from the state because it was the school department - not police - who overspent their budget by \$4M. Over-

spending that calls for criminal penalties under state law.

Yet, the daily paper tripped over themselves day after day during this crisis to blame police, even publishing their salaries (and getting it wrong) while failing to publish the salaries of overpaid administrators in the School Department - many of whom are actually getting raises, even while the city is borrowing money, and cutting services to Methuen taxpayers.

What's worse, in response to the bait and switch propaganda of the daily paper, the city council decided to put public safety at risk by cutting \$1.8M from the police budget. This will result in at least 25 patrolmen being laid off.

We believe it is the height of irresponsibility to reward the school department by giving them an additional \$4M after they overspent. Not to mention giving them even more money in the 2019 fis-

cal budget - all the while punishing the police and the public for the school's misdeeds.

We agree that there needs to be a full criminal investigation into Methuen's finances and a full forensic audit of all spending in Methuen going back at least five years.

But, we find it more than curious that State Rep. Linda Dean Campbell has called for an investigation of the police, but not the schools, and only after "consulting" with the mayor, city council, and the governor's office.

We have to wonder why the daily paper, local, and state officials are working so hard to not only reward the schools for overspending, but also shielding them from any investigation when they are the sole reason the City of Methuen is in this mess to begin with.

The whole situation smells from the top down, including Governor Baker's

office which has changed their story on fiscal oversight more than once.

We know deals were made to pass last year's Methuen city budget, and given the illogical behavior of just about everyone involved we are starting to believe deals are still being made.

It has to stop. Or Methuen will quickly become like Lawrence.

As for the Methuen Police Superior Officers' Union, you can hardly blame them for negotiating the best deal they could for their officers.

If anyone is to blame for inflated police salaries, it's the prior Methuen City Council (which includes Mayor Jajuga who was on that council) for either knowing what was in that contract when they voted on it - or worse - not knowing because they didn't bother to do their jobs and read the contract before giving their approval.

HOW LONG UNTIL BOOKS ARE BURNED HERE?

George Orwell: "Journalism is printing what someone else does not want printed: everything else is public relations."

In our times of phony communication overdrive, increased divisiveness and contentious discourse amid interest driven media and reports favoring powerful corporations disguised as news, writers like myself, who are committed to truth rely on libraries and librarians as sources for accurate information. Allies in our perpetual quest for free access to reliable facts and figures.

Not that I am naïve to reality. I know that libraries too are funded by individuals and institutions who set the standard for what they carry. It was after all the top echelon of Germany's intellectual elite that began censoring books at the behest of the German P.E.N. (Poets, Essayists, Novelists) Center, and in 1933 started the infamous book burnings of works that the Nazi party members considered "un-German" in spirit. Works by some of the most revered German intellectuals such as Brecht, Einstein, Freud, Mann and Remarque, among many other prominent cultural figures.

It was soon thereafter that the famous words by the expatriate German Jewish poet Heinrich Heine, exiled to France, penned more than a hundred years earlier: "Where they burn books they will burn people too" became all too true.

But I was assuming, that in our more enlightened times (how often do we hear: one should learn from the Holocaust?)

clearly, what we should know is that the raping and murdering of innocents evolved from censoring, pillaging and robbing.

All this crossed my mind during my recent telephone conversation with the librarian at the Wellesley Free Library in charge of periodicals. It followed requests by patrons for an inclusion of a greater Boston monthly paper in the Library's Reading Room and made me realize, how close we actually are to the spirit of pre-World War II fascism in Germany, right here in Wellesley. Home of the same named College for women, Babson and public schools considered to belong to the nation's finest institutions of learning.

The patrons, who had repeatedly requested a copy of The Valley Patriot, a monthly, in the Periodicals Room, found it daunting that a new "café-like space" and an "automated Material Handler" were under consideration by the Library, when a simple request for more varied reading material in form of this monthly paper was being denied.

Clearly there were plenty of other café-like spaces in town for "sipping coffee" and whether an "automated Material Handler" was absolutely necessary could be a matter of opinion. But according to Wikipedia the purpose of a library is to hold "books, periodicals, newspapers, manuscripts, films, maps, prints, documents, microform, CDs, cassettes, videotapes, DVDs, Discs, e-books, audiobooks, databases," and other informative materials for research and reading. These days an absolute necessity for those attempting to sort out the facts from the fake, with the influx of biased and inaccurate reporting



The History of The Saint Alfio Society and Feast of the 3 Saints

The history of the Saints Alfio, Filadelfo and Cirino Society goes back to the early years of the twentieth century, Est.1921, and is as much a part of immigrant history as it is of the history of Lawrence, Massachusetts.

The Saints that make up the name of the Society are three brothers martyred in the third century for refusing to denounce their Christian faith. During their lifetime and even after

their death, numerous miracles occurred which are attributed to the intercession of the Three Saints, even today. Since the 1500s, the people of Trecastagni, Sicily have held a grand Festa each May 10th in honor of the Three Saints.

During the early part of the 20th century, immigrants from this region of Sicily came to the Merrimack Valley seeking employment in the numerous textile mills throughout the area.

Often, working conditions were unsafe, medical insurance was not provided and there was no social welfare net for these employees and their families.

To help each other, these Sicilian im-

migrants formed a mutual benefit organization, to provide medical needs, a death benefit and offer food assistance where needed. In short, the immigrants created their own social security.

But there was more than just a mutual benefit charter—these immigrants from Trecastagni and the surrounding towns in Sicily that settled in Lawrence brought their faith and the tradition of the Feast with them. The organization was created in honor of the Three Saints of Trecastagni: Società di Mutuo Soccorso – Santi Martiri Alfio, Filadelfo & Cirino.

The first Feast was held in 1923 and has been an annual event in Lawrence now in its 95th year. Since then, the Saints Alfio, Filadelfo and Cirino Society has maintained the tradition of honoring the Three Saints in the same manner as the original Festa in Trecastagni, Sicily.

Today, the Society focuses not only on its members, but outward into the community, providing scholarships for local college-bound seniors, donating to area charities and offering assistance throughout the Merrimack Valley.



Fiscal Year 2018 State Budget Update

The Massachusetts Legislature recently passed a \$41.88 billion state budget for FY19 and directs a \$367 million deposit into the Stabilization Fund, to ensure our state's fiscal health and protect Massachusetts' future. It also prioritizes our cities and towns, education, and those most in need of help and features no new taxes or fees.

In recognition of the state's strong support for education, the Legislature approved an unprecedented \$4.9 billion in Chapter 70 education funding, which represents an increase of 3.4 percent over the previous fiscal year and increases funding for teacher health care costs by \$39 million. A priority of mine, education funding, also features \$319.4 million to fund the Special Education Circuit Breaker, \$90 million for Charter School Reimbursement, \$68.9 million for Regional School Transportation and \$5 million to fund the Preschool Partnership Initiative.

The budget also provides \$2.5 million for continued support for early childhood mental health consultation services and \$20 million to support high-quality Early Education and Care (EEC) programs; the budget also provides \$10 million to create an EEC workforce development initiative to tie professional development and higher education opportunities more closely to our community colleges.

As part of an ongoing effort to ensure access to safe and affordable housing for the most vulnerable Massachusetts residents, the budget provides \$100 million for the Massachusetts Rental Voucher Program (MRVP), \$32 million for the HomeBASE program, \$20 million for the Residential Assistance for Families in Transition (RAFT) Program, and establishes a \$5 million rapid homeless rehousing program.

To address the ongoing opioid epidemic, the budget includes \$142 million for the Bureau of Substance Addition Services to create five recovery centers in Massachusetts. The budget features \$5 million to support community-based treatment program, \$4.9 million for step-

down recovery services, and \$1 million to provide increased access to Narcan to first responders.

The budget sets aside funds to establish monitoring for hiring, promotion, and preferential treatment occurring within the State Police.

And in addition:

- Provides clear statutory authority to Juvenile Courts to protect unaccompanied immigrant youth aged 19 and 20 from deportation, continuing our long-standing value of protecting the children in our communities

- Creates an annual internal audit and the requirement of annual accreditation.

- Establishes a commission to look at funding for Sheriff departments, with an eye towards encouraging the use of best practices and reigning in rising costs, with a particular emphasis on recidivism reduction

- Introduces a pilot program to promote employment in state contracts with persons with disabilities to expand access to participation in the economy.

- Requires the Administration to acknowledge and sometimes waive the unique tax burden on small businesses with high-turnover workforces that are the hardest hit by the Employer Medical Assistance Contribution (EMAC) Supplement assessment.

- Creates an Office of Health Equity to tackle social determinants of health and environmental justice to improve health outcomes among people of color.

- Expands access to Non-profits working with the state to state discounted Naloxone, helping to make it more available at a lower cost as we continue to combat the opioid crisis

- Establishes a permanent Tax Expenditure Unit in Department of Revenue that would examine the usefulness of every tax credit on an ongoing basis – to ensure our tax payers are receiving worthwhile returns on their investments.

Also, in the budget were important local priorities that I filed and secured, totaling \$800,000:

- \$10,000 for uniforms at the Haverhill Fire Department

“WEATHER 101” WITH AL!

Welcome to August and the last full month of summer.

It is amazing how fast July went by and now we are headed towards the latter part of the summer. July was a hot month. The first week of July was very hot with daytime high temperatures above 90 degrees.

A heat wave occurred in many areas, including Boston, Manchester NH and Concord NH. A heat wave occurs when the high temperature reaches 90 degrees or higher for three or more consecutive days. Boston averaged 2.8 degrees above normal for July.

Manchester NH averaged 3.9 degrees above normal for July and Concord NH averaged 3.1 degrees above normal. The reason for the hot weather was the strengthening of the Bermuda High Pressure System off the east coast.

This upper level HIGH PRESHA! system pushed the jet stream north of our area and put us on the south side which is the hot side of the jet stream. July also turned out to be a wet month with many areas averaging over one inch of rain for the month making for above normal rainfall.

Some of the rain in July was accompanied by thunderstorms, some of which became severe. Some severe thunderstorms occurred during the early morning hours of July 26th. The severe storms generated two EF-1 tornadoes to occur in Worcester county. These tornadoes occurred after midnight during the early morning hours of July 26th. This timing is unusual for tornado development because of the absence of the heating caused by the sun.

After these tornadoes occurred, a cold front moved through Saturday night into Sunday morning July 28th into the 29th. This cold front brought an end to the oppressive humidity from the prior week

when dew points were in the low-mid 70s. This is truly tropical air typical of Florida and the southern states. The cold front moved out to sea south of New England Sunday morning July 29th lowering the humidity and making for more comfortable conditions.

The dew points dropped on Sunday July 29th making for less humid conditions. July would end on a quiet note with some very warm temperatures with tolerable humidity. Towards the last few days of July it looked like the Bermuda High Pressure System in the Atlantic Ocean would regain strength and start moving west towards the east coast and New England. This would bring a return to oppressive humidity as August begins.

During August we will continue to lose daylight as the days continue to shorten. This will cause the average daily high temperatures to fall by the end of the month.

The ocean temperatures are also warmer in August compared to June and July. This will cause peak hurricane season from mid-August to mid-September. This is the time period where maximum hurricanes can form over ocean waters. Hurricanes form over ocean waters where the temperatures are above 80 degrees.

Time will tell how active this year's hurricane season will be. During this last full month of summer remember drink plenty of water so you do not get dehydrated. If you are outside and hear thunder, go indoors. Seek shelter immediately and stay away from windows. Stay away from trees during thunderstorms.

Also remember do not drive your car through flooded roads. Stay away from downed power lines which can occur from damaging winds due to severe thunderstorms. Next month we will recap the weather for August and take a look at this year's hurricane season. Stay safe and enjoy the last full month of the summer of 2018!!

by various print-, internet and other media outlets.

All the more disconcerting was the response given to me upon a repeat call to Anna Dorste, the Periodicals Acquisitions Librarian, in response to this request for the more centrist monthly than most of the other papers offered in the Periodicals Room.

After navigating Dorste's first argument, that "the library's vendor (Revistas) cannot provide it" with the binding offer to secure delivery, she stated: "financial limitations." These were offered to be covered with a donation to the Library for the cost of the subscription to the paper. Nevertheless, she told me, we would have to wait until the beginning of the new fiscal year in July 2018 and then she still couldn't promise the subscription as it was up to her to make the selections.

Upon my inquiry, which criteria she used for her decision, she answered: "Depending on how many people would be reading it."

Perplexed I asked, how that would be determined prior to the paper actually being in the Periodicals Room?

Dorste: "It can't be. Only once it's available."

Ok, I thought, incredulously. This conversation had now totally peaked my curiosity: "So how do you determine how often a paper is read?"

Dorste: "When readers leave it out on the table."

I had to remind myself that I was talking to a librarian, a person of the type I considered informed and educated, perhaps even schooled in logic: "Aren't readers

supposed to put non-circulatory reading materials back where they got them?" I asked.

Dorste: "Yes," was her curt answer. She sounded hostile, a frequent response to my observing – or asking too much, I registered.

"So you can only determine that a paper has been read if someone is sloppy or careless enough to leave it out?"

Dorste: "Yes."

This then was about her deliberately obstructing access to information in my community, the opposite of a library's stated mission in a "free" society.

"Not a very reliable method for an accurate assessment. What do you say?" I asked.

Dorste: "Right."

This conversation had gotten tedious to say the least. So, I finally concluded: "Let's then just cut to the chase, you don't want The Valley Patriot in the Periodicals Room because you are actually limiting the information Wellesley Free Library Patrons should read. That's censorship, isn't it?"

She didn't answer. The silence was deafening. I had hit the proverbial nail on the head.

These days it's politically incorrect to call a "spade a spade." But this spade is shoveling its own grave and that for us all. What exactly does the word "free" mean in Wellesley Free Library? Where freedom of the written word is banned it will be burned, and so will people not fitting into some overall trendy scheme. In some places it's already happening again.

Shootings, Stabbings, 2 Nights of Violence Shatters Peaceful Summer in Lawrence

It's been a historically peaceful summer in Lawrence with violent crime down nearly 50% and murders (so far) this year down by 2/3.

The current murder count in Lawrence is three.

Two of those murders (the Hampshire St. execution on June 6th and the 550 Broadway shooting on May 2nd) have not been solved.

The one murder that was solved was the brutal and savage stabbing on Doyle Street where the killer was still on the scene when police arrived.

Last year at this time there were nine murders in the city and daily calls of shots fired with a dozen people each month showing up at the hospital with gunshot wounds.

So far this summer there have been very few gunshot calls, as a peaceful calm seemed to settle over Lawrence though most of May, June and July.

All of that changed late last month with several police calls of "shots fired" and a surprising uptick in the number of police calls of violence.

SHOOTING, BEATING, KNIFING IN GANG TERRITORY

On Thursday night July 26th, a man on Alder and Juniper St. was shot. The initial call that went over the police scanner was that he was down on the ground, but seconds later the police dispatcher informed officers on their way to the scene that the victim got up and ran towards Lawrence Street.

After an extensive search he was later found without any gunshot wounds, but shell casings were found at the scene.

Later the same night, two more calls for shots fired were dispatched in the same neighborhood but no victims were found.

On Friday night July 27th, a man was beaten with a baseball bat and stabbed with a knife on Juniper Street, just feet from Thursday night's shooting.

The victim was brought to Lawrence General hospital, his condition was not released. The Alder and Juniper Street neighborhood is the center of gang territory in Lawrence.

VIOLENCE SPILLS INTO METHUEN

While violence is on the decline in Lawrence, criminals have crossed the border into Methuen and Haverhill spiking the violent crime numbers in those communities.

Minutes after that violent assault on Juniper St. in Lawrence, a car to car drive by shooting occurred just a few feet over the Lawrence line in Methuen on Tenney Street just a few minutes before midnight.

All units of the Methuen police were sent to the scene and Tenney St. was shut down.



Sgt. McMenamon and on-duty detectives also responded finding five .40 caliber shell casings on Center Street in front of Polanco Market.

A preliminary investigation determined based on evidence found at the scene, witnesses, and video of the incident showed two vehicles traveling south on Tenney St., met side by side in the area of 65 Tenney St.

The vehicles were a light colored sedan and a dark colored sedan. Some report the light car as a Nissan Altima, some witnesses described it as an Acura.

The dark colored car was described as a Camaro or a Maxima, or possibly a Charger.

After a short time the vehicles continued south on Tenney St. as the light colored car accelerated and passed the dark car. As it came to the intersection of Center and Tenney St. a male leaned out the window of the light colored car and began to fire at the dark colored car.

Police received video from Center St. and Tenney St. which captured some of the incident and supported witness statements.

As a result of the suspect leaning out of the window and firing from the light colored car, a bullet entered the southern wall of a home at 65 Tenney St.

The bullet entered the living space of the residence and stopped on the floor, a short distance from where a 5 year old child was sleeping.

The bullet was recovered by state police and casings were found.

Massachusetts State Police photographed the scene and are assisting in the investigation.

3AM - METHUEN SHOOTING JUST OVER THE LAWRENCE LINE

On the other side of Methuen (East Methuen), officers responded to the area of Olive St. and Boston St. for a call of several loud noises that woke up neighbors.

Upon arrival police say they discovered two vehicles with bullet holes parked on Olive St. near the intersection of Boston St. Officers canvassed both streets and spoke with neighbors, nobody was injured.

Police say that a 2011 Honda Civic owned by Luis Gonzalez was the intended target vehicle. The vehicle of a second victim, Woldine Moise of Methuen, was also struck once by a bullet. Police believe that the shooter left the area via Boston St. heading towards Vermont St.

While searching the area police discovered two shell casings and a loaded round

on the ground near the damaged vehicles on Olive Street.

Not far from that live round, police discovered a black plastic garbage bag containing several more empty shell casings in front of 91 Boston Street.

Shell casings recovered were .223 rifle rounds.

Police say that the plastic bag had a hole in it saying it appears the suspects fired the weapon from inside the bag.

Officer Getchell was called to the scene with his canine "Buddy" and did an area search. Nothing further was found.



SHOTS FIRED NEAR MALAYAS IN LAWRENCE AS POLICE LOOK ON

Shortly after the 2am last call for Lawrence nightclubs Saturday morning July 28th, The Valley Patriot was stationed at the corners of Mill and Essex Streets, and Newbury and Essex where half a dozen Lawrence cops were conducting what they call "impact patrol" to stem the pattern of fights and violence of last call patrons all leaving the night clubs at the same time.

That's when a black car drove past police and fired at the crowd leaving Malayas nightclub on Newbury and Methuen Sts.


Police chased a dark colored vehicle down Methuen Street to Union St. and into South Lawrence where the shooter made his way to Rt. 495 South and was able to get away.

Police found no shell casings as is usually the case when a gun is fired from inside a vehicle. Surprisingly nobody was hurt.

WHY IS VIOLENT CRIME DOWN SO MUCH IN LAWRENCE

Love him or hate him President Trump has sent an alphabet soup of federal law enforcement agencies into the city to "Drain the Swamp".

Since last August, undercover agents from the Drug Enforcement Agency (DEA), The U.S. Marshalls, the FBI, Immigration and Customs Enforcement (ICE), the ATF (Alcohol Tobacco and Firearms), and dozen other state and fed-

eral agencies have arrested and deported hundreds of criminals, both here legally and illegally.

In any community there are always a small number of people who commit the majority of crimes, and the numbers show that in Lawrence a great many of those criminals have been removed, making Lawrence safer (though not safe) than it has been in years.

Add to that a new tone by Chief Roy Vasque who is aggressively engaging in a zero tolerance policy on every crime, large or small.

Vasque told me when he appeared on the Paying Attention Podcast last month that tasking his officers with making arrests for minor crimes that would have previously resulted in a warning. Letting those incidents go would usually result in further problems later on.

"What you're seeing there with aggravated assaults (as one example) is that we have a lot of new officers who are basically going out and making arrests where before people wouldn't have been charged. Before, people would be sent on their way after a fight and now we are making arrests and charging more people."

Vasque said that when "quality of life issues are taken more seriously it tends to prevent bigger crimes from occurring."

He cited how the city is now handling traffic violations and calls about loud music and house parties, saying that the city now makes more vehicle stops and when responding to loud parties they log the name of the person who is holding the party, give an official warning and if the police have to go back to that address for the same infraction they are given a hefty fine.

The rest of the media has ignored the progress in Lawrence and the massive reduction in stolen cars, rapes and murders, preferring to flood the city with their satellite trucks the minute a major crime takes place and then fleeing back to Boston when calm returns to the city.

We, here at The Valley Patriot are committed to providing REAL news and a complete picture of what is really going on in Lawrence when there is a violent incident.

But, we also believe that we have a responsibility to report when things start to improve in the city, rather than exploiting individual incidents of violence to always paint a negative picture of Lawrence as a bad and dangerous city.





Valley Towing in Methuen Vindicated by Court Ruling

A judge has dismissed a \$5.5M lawsuit against Valley Towing and two Methuen police officers by Chris Nesbitt, brother of Charlie Nesbitt. Charlie Nesbitt has mounted a social media campaign on behalf of his brother in what some have called "harassment" against Valley Towing accusing the owner of the tow company of violating his constitutional rights. Chris Nesbitt's lawsuit claimed that Valley Towing's owner Ron Parrino illegally junked his car months after towing it and accused Methuen Police Officers Korn and Pappalardo of violating his constitutional rights by refusing to investigate the issue as a criminal matter. Nesbitt also alleged that because Parrino is owner of Valley Towing and also head of the city's licensing board he had used undue influence in that capacity to violate Nesbitt's rights.

Nesbitt told Fox 25 news that Parrino was running a "criminal enterprise".

But, United State's Federal District Court Judge Denise Casper disagreed dismissing the suit.

In her 8 page judgment against Nesbitt, Judge Casper said that Nesbitt couldn't produce documents showing he was even the owner of the car and that she produced no evidence at all as to how Mr. Parrino had used any influence as head of the

city's licensing board to deny Nesbitt his constitutional rights.

"The complaint... does not identify any conduct taken by Parrino in his capacity as a member of the City of Methuen Licensing Board that Nesbitt contends violated Nesbitt's rights."

As for Nesbitt's complaint against Methuen Officers Korn and Pappalardo, Casper wrote, "Nesbitt contends that Pappalardo and Korn improperly used their discretion by failing to investigate his claims regarding the vehicle, thereby violating Nesbitt's rights under the Due Process Clause. ... and The failure by the state to investigate a crime, however, does not generally constitute a violation of the Due Process Clause."

Writing later in her ruling, "...the facts alleged by Nesbitt fail to make out the violation of a constitutional right and Korn and Pappalardo are entitled to qualified immunity."

Nesbitt filed an amended complaint but the judge refused to even rule on it claiming he had not followed the correct procedure to do so.

PARRINO BREAKS SILENCE

Valley Towing owner Ron Parrino has refused to talk publicly about the case, even turning down an offer from Fox25 News in Boston which did an "expose" on



the Nesbitt matter.

Parrino said he was happy to talk with The Valley Patriot, saying that he knew at least The Valley Patriot would report on him fairly, noting that the Eagle-Tribune and other media outlets acted irresponsibly when reporting on the issue.

Parrino told The Valley Patriot that he

has not ruled out a lawsuit for defamation now that the judge has ruled in his favor. He would not say who that lawsuit would be against.

"We are pleased with the court ruling against us and the city, Parrino told The




School Committees Play Vital Role in State Oversight

As of the deadline for this article the City/School budgets have not been fully resolved or finalized, but I hope to provide more information in a future article. In the meantime members of the City of Methuen Charter Review Commission recently discussed the possibility of recommending the elimination of the Methuen School Committee. This suggestion was offered by former Mayor Dennis DiZoglio, who serves as chair of the Charter Review Commission. Even though I didn't want to lend any credence to this suggestion since it's not going anywhere, I felt the need to write about what school committees do for the benefit of those who are curious. The role of school committees in the Commonwealth of Massachusetts is governed by state law and Massachusetts General Laws do not permit the elimination of school committees for good reason.

A short history lesson is in order here. Massachusetts Bay Colony first established public schools in 1647 and the first schools were administered by local town meetings. As the population of the state grew school committees were established in most cities and towns separate from municipal government. In 1826 the Massachusetts Legislature passed a law requiring the establishment of school committees in each city or town to have "the general charge and superintendence" of all the public schools of the town. This system of school governance served as a model for the rest of the nation, which soon followed suit in establishing elected school boards.

In proposing to eliminate school committees in Methuen and transferring

their responsibilities to the City Council, Dennis DiZoglio cited three reasons for combining: (1) Duplication of roles; (2) Efficiency of purchasing; and (3) Distrust of officials. City Councilor and Charter Review Committee member Steve Saba stated that the current system was "just not working." Let's examine each of these reasons given respectively.

Duplication of roles: According to the National School Boards Association website, "Local school boards have responsibility for goal setting, policymaking, community involvement and oversight of administrative aspects for their individual school districts." Massachusetts General Law provides that school committees have three primary responsibilities in the governance of public schools: (1) Establishing Education Policies for schools; (2) Approving and managing a line-item budget; and (3) Hiring and providing oversight of school district superintendents. We can see that these responsibilities are very different from the role and responsibilities of the City Council. It is certainly not a duplication of roles.

Efficiency of purchasing: The Methuen School Department has worked very cooperatively with the city for years. This is true when we consider payroll, health insurance, Medicaid reimbursements, etc. Over the last several years the Methuen School Department has assisted the city with their human resources overload and in maintaining city buildings and fields. There is currently productive collaboration taking place between the School Department and the city with regards to improving Information Technology options in the city. It should also be noted that for the last several years the School



Veterans Legislation Goes to Governor Baker's Desk to Be Signed

I am proud that the Massachusetts Legislature has renewed its commitment to our Veterans by passing the BRAVE Act. As a Veteran and coming from a family of Veterans, I am proud and grateful that Massachusetts continues to honor those that have made, and continue to make, many sacrifices to serve our country.

This legislation increases burial assistance amounts, provides time off for Veterans on Memorial Day (with or without pay at the discretion of the employer), increases the veterans tax work-off program benefits, reserves parking for Veterans at city and town halls, and increases property tax benefits. It also establishes April 5th as Gold Star Wives Day and the last Sunday in September as Gold Star Mothers and Families Day.

Veterans will also benefit from a decrease in the residency requirements related to the Veterans property tax exemptions. Currently, eligible Veterans have to reside in Massachusetts for 5 consecutive years to qualify for the exemption. This legislation reduces the 5 consecutive year requirement to 2 consecutive years and adds Prisoners of War as a qualifying group for property tax abatements, ultimately extending this benefit to more Veterans and their families. Additionally,

the bill increases the Veterans Tax Work-Off Program credit from \$1,000 per year to \$1,500 per year. This program allows Veterans who serve in the community to use the credit to abate property taxes.

An important provision in this bill increases the burial expenses benefit for Veterans in need. The last time this benefit was updated by the Legislature was 18 years ago and set the benefit at \$2,000. Today, the average cost of a funeral is \$7,000 and while funeral homes are still performing burials for Veterans in need, the \$2,000 is inadequate for a proper funeral service. This provision will increase the benefit from \$2,000 to \$4,000 for a funeral costing \$5,000 or less.

Passing this legislation sends a clear message that our state recognizes the unique challenges faced by our Veterans and their families, and that we are committed to providing real assistance to honor their sacrifices.

Women's Defense Corps Legislation Governor Charlie Baker signed into law a bill filed by myself and State Representative Paul Tucker which designates April 2nd as the annual observance of the Massachusetts Women's Defense Corps Remembrance Day. The intent of the bill is to recognize the generous contributions of the approximately 18,000 women who were trained for duty and approved by Governor Leverett Saltonstall to serve the



Commonwealth during World War II.

The Massachusetts Women's Defense Corps (MWDC) were a group of volunteer women dedicated to providing war-related and emergency services to citizens of the Commonwealth.

Their assistance to their country during its time of need evolved into several areas including air raid wardens, drivers, communications personnel, canteen workers, medics, chemical detections personnel, and emergency firefighters. These women, who wore brown uniforms purchased at their own expense, worked closely with the Massachusetts State Guard, the U.S. Army, state agencies, and local communities.

The MWDC was deactivated in 1946 and the only recognition they received was the award of a ribbon for three-years-service. I filed this legislation for the first time in 2013 with former State Representative John Keenan, who is now

the President of Salem State University. When President Keenan resigned from the Legislature in 2014 to accept a position as the City Solicitor of Salem, his successor Rep. Tucker refiled the bill with me for the last two sessions.

These women did not just answer the call, they demanded to serve and their service was very important and inspiring. While there are not many surviving members of the Massachusetts Women's Defense Corps, it is so fitting to provide this recognition as they provided an important service to our country and answered the call. They provide inspiration for all to search to find a way that we can serve our country.

"We chose to keep quiet with the facts and did not talk to the media at all. The media stories were all negative based towards valley towing, especially what has been posted on Facebook with nothing but rumors. It has affected the business with customers gossiping without knowing the true facts of the real story."

"We had tried settling this with the insurance company, Liberty Mutual, on the towing and storage charges on the Honda. After months of storage and towing fees, they will only pay reasonable charges, meaning they won't pay for months and months of storage for a car that is basically worth scrap value. The accident was under investigation for a long period of time by the insurance company."

"Having this case dismissed will hopefully clarify and squash all the rumors against us," he added.

For his part, Charlie Nesbitt, who initially told the Valley Patriot that the Honda was his car, only to claim later on that it was his brother's, but had no valid legal paperwork to prove ownership. The Nesbitts have put back up a Facebook page attacking Valley Towing after taking it down when he lost the suit. He is now claiming on social media that he is appealing the dismissal.

"Charlie was not even the owner or plaintiff of the car, Chris was (allegedly) the owner, driving on some type of NH transporter or dealer plate. The car was never registered to him at the time of the accident. The car came into our possession on 12-17-16 for an accident at Broadway/Osgood St Methuen towed by Methuen Police. The legal owner of the car at the time according to the registry was (name redacted) in Lawrence."

"Once we towed the car, it had been stored here for a period of 6 months with storage being at \$35 a day, plus towing and other fees. Estimated storage would have been around \$5500.00 for a 20 year old car."

Parrino said that the Nesbitts refused to accept anything anyone told them.

"As explained before to Mr. Nesbitt, the police will not get involved since it is a civil matter. He has been told this numerous times but persistently would not accept it. That began leading to his "protests" and antics on Facebook along with calling every media outlet in the area."

Valley Towing has been the subject of pickets and social media targeting by several people claiming that they were treated unfairly, saying the campaign against him is glad the court has given him back his good name.



Lawrence Man Arrested for Threatening Man with Gun Behind Police Station

LAWRENCE – On August 2nd at approximately 12 PM, Lawrence Police Officers Carlos De Los Santos and Jose Gonzalez of Patrol Division responded to Wendy's 55 Hampshire St, which is located directly behind the police station, for a report that a male had just brandished a firearm. Within three to five minutes of the broadcast, Detective Harold Rogers located the vehicle on Union Street in the area of Summer Street. A motor vehicle stop was conducted by Detective Rogers and Officer Abel Cano.

The operator of the motor vehicle, Franklin Mauel Laras age 21 of Lawrence, was taken into custody without incident by Detective Rogers and Officer Abel Cano.

Detective Rogers located a firearm tucked into the waistband of Laras.

A field show up was conducted during which Laras, who is not licensed to carry a firearm was positively identified as the individual who brandished the firearm.

Laras will be arraigned tomorrow in Lawrence District Court charged with assault with a dangerous weapon, and other firearm related charges.

HAVERTHILL MAN GETS 8 1/3 YEARS FOR FENTANYL & HEROIN CONSPIRACY - BOSTON - A Haverhill man was sentenced last week in federal court in Boston for his role in an opioid trafficking conspiracy involving the distribution of fentanyl, heroin, and oxycodone across Massachusetts and Florida.

Jesus Gonzalez, 23, was sentenced by U.S. District Court Judge Denise J. Casper to 100 months in prison and four years of supervised release. In April 2018, Gonzalez pleaded guilty to one count of conspiracy to distribute and to possess with intent to distribute over 100 grams of heroin and/or 40 grams of fentanyl, one count of conspiracy to distribute and to possess with intent to distribute oxycodone, and one count of conspiracy to launder monetary instruments. Gonzalez was arrested in June 2016 for his role in a widespread conspiracy involving heroin, fentanyl, and opioid pill trafficking, as well as money laundering offenses in Massachusetts and Florida. From at least 2014, Gonzalez obtained heroin and fentanyl from sources in Massachusetts and conspired with others to distribute the narcotics, including approximately 230 grams of a mixture of heroin and fentanyl in November 2015. Gonzalez also participated in a conspiracy to obtain oxycodone pills from Florida, have them shipped to Massachusetts, and then distributed. Finally, Gonzalez participated in a conspiracy to launder and conceal the proceeds of the sale of narcotics by using funnel bank accounts to send money to Florida.

United States Attorney Andrew E. Lelling; Brian D. Boyle, Special Agent in Charge of the Drug Enforcement Administration, Boston Field Division; Kristina O'Connell, Special Agent in Charge of the Internal Revenue Service's Criminal Investigation in Boston; Delany De-Leon Colon, Acting Inspector in Charge of the U.S. Postal Inspection Service; John Gibbons, U.S. Marshal for the District of Massachusetts; and Mickey D. Leadingham, Special Agent in Charge of the Bureau of Alcohol, Tobacco, Firearms & Explosives, Boston Field Division, made the announcement today. Valuable assistance was provided by the Massachusetts State Police and the Biddeford (Maine), Framingham, Haverhill, Lawrence, Manchester (N.H.), Methuen, Millis, Natick, Stoughton, and Waltham Police Departments. Assistant U.S. Attorneys Nadine Pellegrini and Craig Estes of Lelling's Office prosecuted the case.

Department has functioned with a biweekly payroll system, which saves the city thousands of dollars each year. The rest of the city has still not transitioned to this biweekly system. The Methuen School Department has certainly been efficient.

Distrust of officials: I find this claim really insulting. First off, unlike the City Council, the Methuen School Committee began preparing a budget in January and had it finalized by March. Members of the School Committee, including yours truly, tried to meet several times with the previous City Council. Our requests for meetings were ignored and the previous City Council refused to meet with us. Members of the previous City Council failed to read

the contracts that put the city in the budget crisis. Some members were too concerned about securing jobs and political favors for themselves and their family members. The Methuen School Committee has gone above and beyond to be transparent with city officials and the public. This can most recently be seen with the current budget fiasco. It should also be noted that the City of Methuen was fined \$3.5 Million by the Commonwealth of Massachusetts 4 years ago for underfunding the schools.

On another note, the Charter Commission members have an important role to play. They should ask questions and examine ways to improve efficiency in the city. I want to thank those who

are serving in this role for doing so. It can be a thankless job. Ultimately they will make recommendations which will have to go to the City Council and then to the voters for final approval. Dennis DiZoglio has been involved in Methuen City politics for decades. He should know better. This begs the question of whose agenda is he promoting? Kudos to Charter Review Commission members Ron Marsan and Dr. Sue Nicholson for challenging the proposal to combine the roles of the Methuen City Council and Methuen School Committee offered by Mr. DiZoglio.

School committees in the Commonwealth of Massachusetts certainly have an important role to play in providing oversight over our public schools. Their responsibilities are vastly different from

those of the City Council. In responding to Mr. DiZoglio's suggestion, I agree with my school committee colleague Bob Vogler, who stated at our June 25th workshop meeting, "This is not worthy to be discussed!"

Town vs. City Government: The Governing Pros and Cons

Groveland and Boston are two vastly different communities in Massachusetts, which have vastly different governing bodies. From a distance, local government simply seems like a smaller version of city government. Groveland has an executive branch in the form of the Board of Selectmen, and a legislative branch in the form of Town Meetings. Boston's executive and legislative branches come in the form of a Mayor and a City Council. The general structure is the same in any governing body in America, but the small differences can vastly change how the community functions alongside their government.

An easy example of this is people's tendency to use the mayor as a scapegoat. They are elected for four year periods and have some control over the branches in his or her government. Despite there being many branches in Boston, with different offices being responsible for certain things, to the denizens of the city, it all gets put on the mayor's head.

This easy blaming is especially evident on social media, where people are complaining to the current Mayor of Boston about traffic, sending him videos of bad drivers, telling him about how their school has no budget, and sending him pictures of cracked sidewalks. Obviously, there are different departments that specialize in each of those categories. Yet, instead of contacting them, everyone goes directly to the top. In a way, that makes sense, however, it makes the mayor's office completely backlogged, while the transportation and education branches of Boston's government won't know about the problem for a week or more.

The opposite thing happens here in Groveland. All Selectmen are elected for three years. Some Selectmen were elected on different years than others; the chair, O'Neil, is up for reelection in 2019, Dube-Carpenter and Dunn are up in 2020, and Watson and Wood are up in 2021. Most people are aware that they have a board of selectmen that they elected, but few think to contact them when they have a problem. They only meet bi-weekly, which means their response time is extended, and there is no single person that has unrivaled power in the town government because the board must have a majority

vote to pass most things. That in mind, the taxpayers of Groveland don't regularly think of the Selectmen as being able to fix whatever problems are apparent in the governance of the town.

In actuality, they have a significant influence on local law. They appoint other townspeople to certain boards and commissions and have contact with larger governmental figures. No individual on the board is as powerful as the mayor, but together they have the same duties and function similarly.

Having Town Meetings instead of a City Council has the same obvious difference as having a Board of Selectmen instead of a Mayor. On a City Council, the townspeople have less input, yet it is much more efficient.

The reason for this difference is that in Groveland, no one is searching for immediate change, but many are looking for a voice in what happens in their town. In Boston, where things are always changing, and new things are always being asked, it's necessary to have a decisive governing body instead of one run solely by and for the people.

In both styles of governance, though, people seem unclear about how to contact the officials who can help them, so here is a quick summary for anyone who wants to make a change in their local or state government. If there is a problem being voted on nationally, or that people in DC are voting on, contact state legislature via phone or email, as they are more likely to pay attention to that than an email. If there is an issue in town, then go to the next town meeting to speak on that issue, or contact the head of the board relating to the issue.

Hopefully, everyone will use that information, because what is the point of a democracy if the people don't take advantage of the voice that they have in it?

Rep. José Tosado Embodies State House's 'Failure To Protect'

State Auditor Suzanne Bump recently released an audit on complaints handled by the Division of Professional Licensure.

Almost every profession requires a license these days. The promise made by the State for interfering in the people's right to earn a living is that it would be the watchful guardian protecting the public. Candace Sloan, who was illegally appointed by Charlie Baker to a consecutive third term as state medical board chairperson, is thus compelled to say, "We are passionately committed to public safety!" while throwing patients out on the street.

Bump's audit found that 25% of complaints were not handled within the required 60 days. These complaints involved "gross negligence, incompetence or substantial violations of regulations" including "people practicing without licenses, unsanitary conditions and fraud."

Any normal person would find this immediately shocking.

Instead, Rep. José Tosado, member of the Joint Committee on Consumer Protection and Professional Licensure, told Kristin Palpini of the Berkshire Eagle: "We absolutely are aware of the report. If things aren't fixed, [the joint committee] can call in and hold a hearing; we can talk about the issue and provide direction. At this point, it's not at that level."

On July 23, 2018 I emailed Rep. Tosado - "Based on the Berkshire Eagle report pasted in above, you have declared that "allegations of people practicing without licenses, unsanitary conditions and fraud" do not rise to the level where you feel compelled to even hold a hearing, let alone do something useful. Please declare what would rise to the level that compels you to even "hold a hearing" and if that takes people dying at the hands of unlicensed professionals, how many deaths would qualify?"

On July 27, 2018 I followed up with a certified letter. And forwarded that email to Sen. Barbara L'Italien, the head of that Joint Committee and now running for Congress. The response has been, as Tom Duggan says, "crickets".

Then again, this is not surprising given the evidence repeatedly before our eyes. The State allowed an African man to retain his passport after he was booked

for rape here. He flew out of the country immediately. The State allowed a murder suspect out on bail to remain on bail despite repeatedly violating his bail conditions. That murder suspect then went on to kill a new father the day he was to bring his wife and baby home from the hospital.

The reason these occur repeatedly is because within the State House there is total contempt for the very concept of governance. No state employee is ever haled in even for a hearing, let alone fired for failing to protect the public.

This contempt of course does not originate within the State House. Representatives and Senators bring that contempt in with them when they assume office. Take our José Tosado for instance. Prior to becoming the state rep for Springfield, he was the Vice-Chair of the Police Commission during the time serial-killer Stewart Weldon collected 68 charges on his rap sheet.

The Springfield Republican reported that Springfield Police did not open a case against Weldon for raping a woman even after Chicopee Police informed them of the results from CODIS of the rape kit that had been collected from the victim at Baystate Hospital and that it matched another Springfield case from 2009. Springfield naturally deny that Chicopee informed them but stay mum about why they did nothing about the 2009 complaint.

It is easy to blame front desk cops. But the Weldon crime spree unerringly points to a total failure of leadership at the very top. If Springfield had taken Weldon off the street for that rape and previous crimes, three women would still be alive now. If Chicopee had cared enough to ensure Springfield knew about the CODIS results, three women would still be alive now.

Because the State House will never hold State employees responsible for failing to protect the public, this situation will repeat. And each time it recurs, the State employee's alleged "privacy" rights will trump the State's duty to protect the public.

Similarly, the minute the State coerced professionals to obtain a license to continue earning a living, it took on the non-transferable duty of protecting the public from those who now hold a license. The

BENEATH THE SURFACE

The Church and the Death Penalty

Pope Francis has altered one section of the Catechism of the Catholic Church (CCC) to include the 'inadmissibility' of the death penalty. Many faithful Catholics are in a state of disorientation and confusion because it appears to them that the pope may have changed an essential doctrine of the Church. I believe these fears are unfounded.

First, it is the faith of Catholicism that the Holy Spirit keeps popes from teaching error on a matter of faith or morals when teaching ex cathedra (in his official authority from the chair of St. Peter). Dogmas and defined doctrines cannot be changed and what is intrinsically evil can never become good. However, non-infallible teachings of the Church are subject to alteration due to historical circumstances or accumulated insight, which the Spirit who animates her assists in bringing to light. Capital punishment, in my fallible opinion, falls into this category.

The essential moral element on the death penalty is that the innocent must be protected by the state from unjust aggressors. This is natural law and unchangeable. Hence, if a society does not have the means to protect the innocent they may have recourse to the death penalty. How, when, or if it is administered is a matter of prudential judgment, which is circumstantial and changeable.

The development of this doctrine was first seen in Pope John Paul II's *Evangelium Vitae*, and later inserted into the CCC #2267. It read as the following:

"Assuming that the guilty party's identity and responsibility have been fully determined, the traditional teaching of the Church does not exclude recourse to the death penalty, if this is the only possible way of effectively defending human lives against an unjust aggressor. If, however, non-lethal means are sufficient to defend and protect people's safety from the aggressor, authority should limit itself to such means, as these are more in keeping with the concrete conditions of the common good and more in conformity with the dignity of the human person. Today, in fact, as a consequence of the possibilities which the state has for effectively preventing crime, by rendering one who has committed an offense incapable of doing harm - without definitively taking away from him the possibility of redeeming himself - the cases in which the execution of the offender is an absolute necessity are very rare, if not practically non-existent."

Here we see John Paul II respecting the tradition that the death penalty, in theory, may be utilized if necessary to protect the innocent, while pointing out that in modern times these situations "are very rare, if not practically non-existent." It is from here that Pope Francis goes a little further. After recognizing the Church's tradition on the death penalty, the new CCC #2267 now states:

"More effective systems of detention have been developed, which ensure the due protection of citizens, but, at the same time, do not definitively deprive the guilty of the possibility of redemption... Consequently, the Church teaches, in light of the Gospel, that the death penalty is inadmissible because it is an attack on the inviolability and dignity of the person, and she works with determination for its abolition worldwide."

Both popes seem to recognize four things: 1) When there is the way and means to keep the innocent safe without killing the criminal, capital punishment should not be considered. 2) Human dignity is not fully extinguished by committing evil heinous acts. 3) Opportunity for rehabilitation should accompany punishment. 4) All nations today should work toward creating the conditions that would make capital punishment unnecessary and illegal.

This teaching has not been met with open arms by all Catholics. Often there is a 'heart' problem that accompanies the intellectual disagreement. Being Christian means to be transformed from the inside out by divine life, and this can be measured by one's response to this command of Christ: "Love your enemies, and pray for those who persecute you" (Mt 5:44-45).

To get an indication of how many people have internalized this fundamental aspect of Christianity, mention the names of Hitler, Stalin, or if you're in the presence of a liberal progressive, Trump. But hatred often reigns in our hearts to the point where it's difficult to discern clearly and objectively what is the best action. Vengeance can easily be interpreted as justice. In this respect, those whose hearts are stuck in neutral with the vice of harboring anger or 'getting even' may be helped to spiritual growth by reflecting on the new version of the CCC #2267.

Let's get right into John as there is so much to say and less space to say it. John was born John Winston Lennon on October 9, 1940. He was named after a grandparent and Winston Churchill. His mom was Julia, and his dad was a merchant seaman named Alfred. His dad was away when John was born and he was away a lot during the beginning of John's life, but the checks came into the family and things were cool, until the day the checks stopped and Alfred went AWOL. By the time he finally showed up, about six months later, Julia was already with someone else and told Alfred the marriage was done. There was a lot of nasty family problems and Julia's sister, Mimi, thought social services should get involved and they made Julia give John up to her. Alfred was secretly taking John out of the area but Julia found out and followed. They fought and finally Alfred left and John went back to Mimi's to live. John didn't see Alfred for another twenty years. Mimi and Uncle George kept John and Julia would visit often.

Julia would visit John and would play different types of music for him to enjoy. Of course, Elvis was in there. She also taught John how to play the banjo. His first song was "Ain't That A Shame," by Fats Domino.

As for religion, he was raised Anglican. In school, John passed the 11+ Exam and went to Quarry Bank High School in Liverpool. He didn't do very well with his academics, but he was quite the artist and class comedian. At about the age of 16 Julia bought John his 1st guitar. He had to promise to keep it at her house as her sister wanted John to work harder in school and get off the music for a while.

Julia was accidentally killed after being struck by a car while walking home from visiting John. He was 17 years old. This isn't good for any young boy. He failed his exams, but with the help of his aunt

and his headmaster they got him into the Liverpool College of Art. Because of his unwillingness to conform and his disruptive behavior, he was thrown out before the last year.

John had gotten himself into the "skiffle" craze when he was about 15 years old. He met Paul McCartney and they were in a group called the Quarrymen. They played some skiffle and also tried to play rock and roll. Paul knew George Harrison and we all know about the upper deck bus audition. So, John invited George to join the group. Neither family liked each other as Aunt Mimi thought they were all lower class, and Paul's father thought Paul would get into all kinds of trouble hanging around with this lot. A friend of John's from school was Stuart Sutcliff. He was asked to join the group on bass. So, these four young men were the earliest form of "The Beatles" in 1960.

Hold the phone!! Didn't something else happen in there somewhere? What about Cynthia Powell? Cynthia was a friend of John's from school. She had it bad for John well before the Beatles or the Quarrymen. They dated and got heavily involved. She even went to some of the Hamburg gigs. He found out she was pregnant in 1962. So, he thought they should get married. August 23rd was their marriage date and John was performing that night. With the Beatle craze going on Brian Epstein thought it would be best to keep this under wraps for a while. Julian was born April 8, 1963. John wasn't even there for the birth as he was on tour. He met his son when he was already three days old.

As with Ringo Starr and George Harrison, I am not going further, here, into the Beatles as this column is on John Lennon and The Beatles will be shortly in the future.

John split up with the Beatles in September of 1969. There had been lots of rumors, but John was done and no one knew for almost a year. John had a lot of irons on the coals, though. "How I Won The

If you want to take it to the next level you can track your physical activity by downloading a fitness app that may let you enter information to help track your





Merchant vessel, SS Lone Jack, after a the ship was damaged in a torpedo attack. The destroyer escort picked up over sixty survivors and sent salvage parties aboard the stricken ship to keep her afloat.

After Germany surrendered, both Petty Officer Gallant and the USS Hammann sailed for Cuba for additional training operations at the Guantanamo Bay Naval Base to get the ship ready for the invasion of mainland Japan. Training of her crew completed, the Hammann transitioned the Panama Canal to join Allied Naval forces in the Pacific. The ship and her crew had defeated the Nazi's and secured freedom in Europe but was needed for the upcoming invasion of mainland Japan.

After Japan surrendered in September of 1945, the USS Hammann was decommissioned at Green Cove Springs, Florida, and she was placed in reserve. The USS Hammann remained out of commission in naval reserve until she was stricken 1972.

Both John's ship, and his military service are mirrors of each other, John was a civilian, a recent graduate of Haverhill Trade, brought in to the Navy after Pearl Harbor. The Hammann, a Destroyer Escort, built in just a few weeks, by shipyard workers in 24/7 shifts for the Navy, to avenge Pearl Harbor. John shared his two most vivid memories of the war with me, foremost was meeting his wife of seventy four years at Hampton Beach, New Hampshire. The other, much more painful, was a good friend from the USS Hammann who drowned on a recreational swim in the Panama Canal, shortly before the war ended.

Typical of the "Greatest Generation", John's fondest memory of his military service during World War II was coming home after VJ Day. He was already married to his wife Ellen Claire Murphy when the war ended, and the couple had a son. Post War, they contributed to the American "baby boom generation" with a family of one son and six daughters.

And just like the rest of his World War II veteran peers, John came home quietly and focused on supporting his family, first as an industrial electrician for CBS Hytron, later he owned a soft drink bottling company, and finally, ending his working life selling real estate. He was clear in speaking to me, that real estate was his favorite occupation. His family today consists of seven children, seventeen grandchildren, twenty seven great grandchildren, and one great, great, grandchild. He and his wife Ellen spent seventy four years together as a married couple.

Similar to every other interview I have done on the heroes of the "Greatest Generation", John said little of the Battle of the

Atlantic, mainly talking about his family. He played the piano and organ, his wife liked to sing, the house was full of music, love, and children. He said marrying his wife was the only smart thing he ever did in his life. John's wife used to say, "there are words in silence". Thought provoking and fitting, because I think that during these interviews, all of these veterans are very silent on their own heroics, but, also very proud of the exploits of their comrades, and what they did as a generation, saving both our nation and the rest of the world from tyranny.

John's interview notes matched the official U.S. Navy records of his ship neatly and perfectly, at ninety eight, his recall of events over seventy five years ago was spot on. Additional thanks to William Wallace, my brother from the Knights of Columbus Catholic Fraternal organization, who was invaluable in setting up this meeting, and very helpful in getting John talking about his U.S. Naval service during and shortly after World War II, his career afterwards, and his family, which was and is John's passion. In the room I interviewed John, you cannot see out his windows. Why? The window panes are covered top to bottom with family photos.

All U.S. Navy and U.S. Coast Guard Enlisted Sailors have BOTH a rating, in John Gallant's case Electrician's Mate First Class, AND a rank, John served our nation with the rank of Petty Officer First Class. A Petty Officer First Class is equal in rank to a U.S. Army or U.S. Marine Staff Sargent, or a U.S. Air Force Technical Sargent. On board U.S. Navy Ships and U.S. Coast Guard Cutters, all seamen have to be tactically (their rank/leadership role) and technically (their rating) competent. Otherwise the ship simply will not sail. Promotions are based on skill as a leader (rank) and technical skill (rating). This system is unique to the maritime services. Leadership and technical skills are equally weighted and sailors cannot neglect either, regardless of the year being 1945 or 2018.

Hulu's 'Castle Rock' is Not Just for Stephen King Fans

A death row attorney returns to his hometown of Castle Rock, Maine after receiving an unexplained call for help from the local prison in a new psychological mystery series from J.J. Abrams and Stephen King.

'Castle Rock,' Hulu's newest series, has a lot to enjoy. While it may appear that it will primarily appeal to Stephen King fans, that isn't so. In fact, you do not need to have ever read a single word of Stephen King to enjoy this series. But it may enhance the experience.

'Castle Rock' takes place in the fictional Maine town of, you guessed it, Castle Rock. This is the town where many of Stephen King's most famous stories take place. King fans will notice other characters from his stories mentioned in the newspaper clips shown in the opening credits. But the story is not based on any King work, it is specifically scripted for this series.

So far, through the first 3 episodes, the show doesn't try to cram in too many references to past King works, but instead focuses on just a few members of this small, but spooky and mysterious, Maine town. This is a good thing. For the viewers who haven't read much of King, you certainly don't want to get overloaded with references that you may not understand.

The first season of 'Castle Rock' begins with the disappearance and recovery of a young boy in 1981. Fast forward to current day and that young boy, Henry Deaver (Andre Holland), is now a defense attorney working in Texas who returns home after getting a mysterious

anonymous phone call from Shawshank Penitentiary. When he returns he finds his old next door neighbor Molly (Melanie Lynskey), his mother Ruth (Sissy Spacek), her friend and former Castle Rock Sheriff Alan Pangborn (Scott Glenn), and a few other locals who somehow will connect to Henry's reason for coming. Bill Skarsgard, who most recently played Pennywise the clown in the recent film adaption of King's famous novel IT, plays the most pivotal man to Henry's return, a prisoner at the penitentiary.

Castle Rock's appeal is that it has a dark mystery, and a darker evil, at the center of the small town. And like most of King's stories, the parts that are the most interesting and intriguing are found not just in the mystery but in how the characters involved in it react to the events, how they treat one another, and also how their actions are judged by the other characters in the story.

'Castle Rock' is a must see series for fans of Stephen King, but it's also a must see series for fans of good TV and fans of dark and compelling mysteries.

'Castle Rock' premiered July 25th on Hulu. New episodes are released every Wednesday through September 12th.


New Pet

Your neighbor's cat has kittens and they are weaned and ready to be adopted. You hold one of the wiggling furballs for a minute and instantly you fall in love. You weren't really looking for a kitten, but before you know it you find yourself at the pet store purchasing kitten food, a litter box, and an assortment of toys. It is easy to get caught up in the excitement of a new pet, but before you decide to take this little life home, there are some things you need to think about.

Do you have pets at home already? If you have a 14 year old cat at home he may not appreciate the energy that is about to come his way. A new kitten, however cute, will likely add stress and discord to a household with older pets. Maybe you have a 1 year old cat that could use a bit of companionship while you are at work. In this case, a kitten probably makes sense. No matter the situation, think about the pets you already have and ask yourself if it is really the right decision to add another animal to the household.

If your pet is going to spend every day in the basement or in a crate, is it really the right decision to get one? Animals can live for a long time. Before you commit to bringing a new animal home, put some thought into it. Make sure it is the right decision for you, your family, and for the animal.



PAWS II Bill Protecting Animal Welfare and Safety Approved by MA House and Senate

Boston - Legislation intended to enhance humane treatment of animals, and punish those who engage in animal cruelty, has received final legislative support following approval by the House and Senate today on Senate Bill 2646, Protecting Animal Welfare and Safety.

The legislation furthers anti-abuse measures first secured in the 2014 Protecting Animal Welfare and Safety bill. Senate Minority Leader Bruce Tarr (R- Gloucester) led lawmakers to adopt the bill, also known as the PAWS Act, following the discovery of extreme abuse and cruelty in the case of a dog that was stabbed, burned, cut and had bones broken. The "Puppy Doe" case led to the arrest and conviction of Radoslaw Czerkawski who was recently convicted of 12 counts of animal cruelty and sentenced to 8 to 10 years in prison.

"PAWS II builds on the foundations of our original law and ensures that abuse is reported and enforced, and that our animal control laws reflect the seriousness of animal abuse," said Senator Tarr. "Puppy Doe inspired me and many others to take strong legislative action to increase protections for animals and prevent animal cruelty and neglect. Animals deserve humane treatment and protections from those who would abuse them."

"This long-overdue legislation is one of the most important steps Massachusetts has taken in years to systematically protect pets and wild animals against abuse, cruelty, and mistreatment," said Senate President Karen E. Spilka (D-Ashland). "As a longtime advocate for the rights of animals and those who own them responsibly, I'm proud and relieved to see this language written into law."

"This legislation furthers the Commonwealth's commitment to protecting the health, safety and well-being of animals," said State Senator Adam G. Hinds (D-Pittsfield). "Acts of animal cruelty will not be tolerated and those who commit these terrible actions should be on notice that such abuse is punishable by law."

Tarr said that in addition to lessening animal cruelty there could be a corresponding reduction of crimes against people citing a Massachusetts study which found that a person who has com-

mitted animal abuse is five times more likely to commit violence against people.

Key provisions of the animal welfare bill, Senate Bill 2646, an act to Protect Animal Welfare and Safety in Cities and Towns, include those which:

- Expand potential for abuse reports – Permits animal abuse be reported by Department of Children and Families, the Department of Elder Affairs, and Disabled Persons Protection Commission.
- Adds animal control officers as mandatory reporters of child abuse, elder abuse, and abuse against disabled persons

- Ensure efficient enforcement of animal control laws – Increases fines for violations of dog control laws up to \$500 for a fourth offence.

- Double the hit and run penalty for an accident involving dogs & cats – From \$50 to \$100 for a first offence – \$500 for subsequent offences and the cost of medical expenses, and or imprisonment in a house of correction for not more than 6 months

- Prohibit the drowning of animals – Declares that drowning of animals is a violation of law for non-licensed trappers or those registered with Fish and Wildlife

- Prohibit engaging in sexual contact with an animal

- Remove automatic killing of animals involved in animal fighting – Removes a requirement to automatically kill animals involved in animal fighting. This bill creates other options for these animal victims

- Add animal crimes to the list of offenses that serve as the basis for a request for a dangerousness hearing

- Examine options to prohibit discrimination against specific dog breeds – Requires insurance companies to collect and report data of dog related incidents

- Require abandoned animal checks in vacant properties – Property owners and landlords must check property for abandoned animals within three days following a foreclosure or termination of tenancy

Senators gave initial approval of the bill unanimously in March. The House and Senate have enacted the bill which now moves to Governor Baker for his signature.

MA Man Pleads Guilty to Sex Trafficking Women by Exploiting Their Opioid Addiction

WASHINGTON – Rashad Sabree, 37, of Boston, Massachusetts, pleaded guilty today in federal court in District of Maine to two counts of sex trafficking by force, fraud, or coercion, announced Acting Assistant Attorney General John Gore of the Justice Department's Civil Rights Division, U.S. Attorney Halsey B. Frank of the District of Maine, Harold H. Shaw, Special Agent in Charge, FBI Boston Division, and Peter C. Fitzhugh, Special Agent in Charge, U.S. Immigration and Customs Enforcement's Homeland Security Investigations (HSI) Boston.



"With today's plea, Sabree is accepting responsibility for his crimes, while his victims continue to recover from the abuse suffered at his hands. This case demonstrates the FBI's unwavering commitment to work with our law enforcement partners to hold sex traffickers like him accountable."

"Homeland Security Investigations is proud to have assisted in this investigation, a case which clearly exposes the false claim that commercial

sex trafficking is a so-called "victimless crime," said Peter C. Fitzhugh, Special Agent in Charge, U.S. Immigration and Customs Enforcement's HSI Boston. "Close law enforcement coordination in this case has allowed justice to be done to the perpetrators of these vicious crimes and to, hopefully, provide some measure of compensation for the victims."

In accordance with the plea agreement, the defendant faces a sentence of 15 to 17 years in prison. He is further subject to a maximum fine of \$250,000 and mandatory restitution to the victims. Sentencing will be scheduled on a later date after the U.S. Probation Office completes its presentence investigation report.

The District of Maine is one of six districts designated through a competitive, nationwide selection process as a Phase II Anti-Trafficking Coordination Team (ACTeam), through the interagency ACTeam Initiative of the Departments of Justice, Homeland Security and Labor. ACTeams focus on developing high-impact human trafficking investigations and prosecutions involving forced labor, international sex trafficking and sex trafficking by force, fraud or coercion through interagency collaboration among federal prosecutors and federal investigative agencies.

The case was investigated by the FBI, U.S. Immigration and Customs Enforcement's HSI Boston, and the Biddeford Police Department, with assistance from the Maine State Police and the Sanford, Kittery, and Portland Police Departments. It is being prosecuted by Assistant U.S. Attorney Julia Lipez and Trial Attorney William E. Nolan of the Civil Rights Division's Human Trafficking Prosecution Unit.

According to court documents, the defendant coerced two young women to engage in commercial sex acts in Maine between December 2015 and Jan. 5, 2016, by exploiting their heroin addictions, verbally abusing them, and threatening them with violence. The defendant controlled the victims by supplying them with just enough heroin to avoid opiate withdrawal, which involves severe pain and physical sickness, and then threatening to cut off their supply and cause them to suffer withdrawal if they refused to engage in commercial sex. On Jan. 5, 2016, a motorist called 911 after observing the defendant striking one of the victims while driving on I-95 towards Massachusetts, resulting in the defendant's arrest.

"This defendant committed sex trafficking by exploiting the opioid addictions of these women, using their vulnerability to coerce them into commercial sex for his gain," said Acting Assistant Attorney General John Gore. "The Department of Justice will continue to work tirelessly to seek justice on behalf of victims and survivors of human trafficking."

"This case demonstrates the important role that the public can play in helping to protect those who are vulnerable," said U.S. Attorney Frank. "We encourage the public to say something if they see something. Here, thankfully, a good citizen did just that."

"This defendant preyed on the addictions of his victims and brutally exploited them in a scheme driven by cruelty and greed," said Harold H. Shaw, Special Agent in Charge, FBI Boston Division.


